It is very difficult for the existing staff to attend to all the new work of the Directorate of Women and Children's Welfare in addition to its existing work load.

Subject:- Separate l'irectorate for Namen & Children's Welfas

PRESERVE At present the Department of Social Welfare, looks after several schemes concerning Women and Children's Welfare and the Director of Social Welfare is the ex-officio Chief Inspector of Certified Schools. In view of the increased in the activities of the Department of Social Velfare, it has become difficult for the Director to have effective supervision over the many activities of the Department including those relating to Momen and Children's Welfare.

buring the current year a number of schemes relating to Women and Children's Welfare has been taken up for implementation keeping in view the fact that the current year is the International Women's Year. Certain other schemes relating to Welfare of Homen and Children are dealt within other departments. It is felt necessary to ensure effective co-ordination of the implementation of the various schemes by different departments meant for the Welfare of Women and Children. Therefore, there is need for constituting a separate Directorate. Further in view of the growing importance of the subject. Covernment have created a Separate Hinistry for Velfare of Women and Children in the State with effect from 28-10-1974.

After Careful consideration of all aspects of the matter, Covernment are pleased to direct the Creation of a separate Directorate for Women & Children's Welfare in the State with immediate effect.

Sanction is also accorded to the creation of a post of Director of Women & Children's Welfare to head the Sald Department. This post will be filled by an officer from the Senior I.A.S. or K.A.S. Scale.

The Director will be in charge of all programmes connected with Women and Children's Welfare, in the State, Viz.,

- e) Remand Homes; and f) Special Nutrition Programme.

In addition the Director will also be incharge of all matters connected with:

i) Karnataka Council for the Welfare of Women and Children; j) Such other functions as Government will allocate from timeto time.

The Director will be a member of the Karnataka State
