ORDER NO. SWL 199 SJD 75, BANGALORE DATED: 14TH NOVEMBER 1975

PREAMBLE: In the Government Order read at (1) above, sanction was accorded for the Creation of a separate Directorate for Women & Children's Welfare, and also for the creation of the post of Director of Women & Children's Welfare to head the said Department. The following subjects are attached to the said Directorate.

- a) Education and Welfare of Physically Handicapped Women Welfare.
- b) Non-Institutional Services and Correctional Homes, i.e., State Homes, Reception Centres.
- c) Women Welfare.
- d) Certified Schools,
- e) Remand Homes.
- f) Special ~~Nutrit~~ Nutrition Programme.
- g) The State Committees for ~~Stk~~ Children's Welfare & Recreation
- h) Karnataka Council for the Welfare of Women & Children and
- i) Such other functions as Government will allocate from time to time.

In the Notification read at (2) above, the Director of Women & Children's Welfare has been appointed as Chief Inspector of Certified Schools.

In the letter read at (3) above, the Director of Women and Children's Welfare has sent proposals for the sanction of staff to the said Directorate to enable the Directorate to take up and implement the various schemes of the Department including new schemes such as Integrated Child Development Services, Promotion of Multipurpose Consumers Co-operative Societies, Fisher Women's Co-operative Societies, Organisation of House Keepers Training Courses, Publication of Women's Journal to disseminate enlightened thinking on the subjects such as Dowry, Widow, Marriage, Superstitious customs and traditions etc., At present no additional staff has been sanctioned to the new Directorate apart from the post of Director. It is very difficult for the existing staff to attend to all the new work of the Directorate of Women and Children's Welfare in addition to its existing work load.

The Director of Women & Children's Welfare ~~has~~ has therefore requested Government to sanction additional posts for the Directorate of Women and Children's Welfare

Creation of...

PREAMBLE:- At present the Department of Social Welfare, looks after several schemes concerning Women and Children's Welfare and the Director of Social Welfare is the ex-officio Chief Inspector of Certified Schools. In view of the increased in the activities of the Department of Social Welfare, it has become difficult for the Director to have effective supervision over the many activities of the Department including those relating to Women and Children's Welfare.,

During the current year a number of schemes relating to Women and Children's Welfare has been taken up for implementation keeping in view the fact that the current year is the International Women's Year. Certain other schemes relating to Welfare of Women and Children are dealt within other departments. It is felt necessary to ensure effective co-ordination of the implementation of the various schemes by different departments meant for the Welfare of Women and Children. Therefore, there is need for constituting a separate Directorate. Further in view of the growing importance of the subject, Government have created a Separate Ministry for Welfare of Women and Children in the State with effect from 28-10-1974.

ORDER NO. SWL 106 SJD 75 BANGALORE DATED 30TH JULY 1975.

After Careful consideration of all aspects of the matter, Government are pleased to direct the Creation of a separate Directorate for Women & Children's Welfare in the State with immediate effect.

Sanction is also accorded to the creation of a post of Director of Women & Children's Welfare to head the said Department. This post will be filled by an officer from the Senior I.A.S. or K.A.S. Scale.

The Director will be in charge of all programmes connected with Women and Children's Welfare, in the State, viz.,

- a) Education and Welfare of Physically Handicapped.
- b) Women Welfare;
- c) Non-Institutional Services and Correctional Homes, i.e. State Homes, Residential Centres;
- d) Certified Schools;
- e) Remand Homes; and
- f) Special Nutrition Programme.

In addition the Director will also be incharge of all matters connected with:-

- g) The State Committees for Children's Welfare and recreation;
h) Dal Bhavans.
i) Karnataka Council for the Welfare of Women and Children;
j) Such other functions as Government will allocate from time to time.

The Director will be a member of the Karnataka State Social Welfare Advisory Board.

The Expenditure on this account shall be met from the provision made under the head of account "288 Social Security and Welfare-D-Social Welfare-1-Direction and Administration-1-Chief Inspector of Certified Schools (PLAN)" during the year 1975-76.

Orders regarding appointment of the Officer and posting of Staff for the Directorate etc., will issue separately.

Sub: Changing the name of the Department of Women & Children's Welfare as the Department of Women & Child Development.

READ: Letter No. DWC/Plan/CN of Dept: 90-91, dated: 27.8.1990 from the Director, Women & Children's Welfare, Bangalore.

PREAMBLE: The Director of Women & Children's Welfare in their letter dated: 27.8.1990 has stated that concept of Welfare activities for Women & Children has undergone a change in recent year. It is perceived that Women & Children need economic development with social justice and not so much "Welfare" which has other connotations. The nomenclature has been appropriately changed to Women & Child Development at Government of India level. The Director has suggested to change the name of the Department as "Women & Child Development" instead of the present nomenclature "Women and Children's Welfare Department" and has requested to issue necessary orders in this regard.—

After careful consideration, Government are pleased to order that the present Department of Women & Children's Welfare shall be named as "Department of Women & Child Development" with immediate effect.
